<p>Project Name or Project/ Program Title Sacramento City HPRP</p> <p>Quarterly Activities/ Project Description The City of Sacramento is using HPRP funds for both homelessness prevention and rapid re-housing. The City has allocated funds to five nonprofit subgrantees in the county, as well as to the Sacramento County Department of Human Assistance (DHA). Three of the subgrantees are primary HPRP providers (each serving a different geographic area in the county), one provides housing-related legal services to HPRP clients throughout the county, and one performs intake services. The City is leveraging additional Federal and non-Federal funding sources to expand the reach of the program beyond what could be accomplished with HPRP funding alone. Using all funding sources, the City expects to prevent homelessness for about 500 households and end homelessness for about 500 households. It is focusing on providing a combination of financial assistance and services to individuals and families who are homeless or about to become homeless.
